**ARTICLES OF INCORPORATION
OF
CONIDARIS DEVELOPMENT COMPANY**

ARTICLE ONE

The name of this corporation is CONIDARIS DEVELOPMENT COMPANY and the mailing address of the corporation shall be 15645 Pine Ridge Road, Fort Myers, FL 33908.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

ARTICLE THREE

The duration of the corporation is perpetual.

ARTICLE FOUR

The general purposes for which the corporation is organized are:


