ARTICLES OF INCORPORATION

OF

OTANG 22 PAIRS: 20 THE UNDERSIGNED, have executed the following document for the purpose & forming above named corporation under the laws of the State of Florida, and as incorporator, hereby adopts the following Articles of Incorporation.

ARTICLE I- NAME

SHELL BACK ENTERPRISES, INC.

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE
