I am the tax return preparer for the above referenced Corporation. Enclosed please find a 2005 For Profit Corporation Reinstatement for the Corporation along with a check in the amount of \$300. The Corporation was administratively dissolved for failure to file the annual report due 5/1/04.

The Corporation closed its office located at 9951 Atlantic Blvd, Suite 248, Jacksonville, FL 32225 in early 2003 and began using a Post Office Box as its business address. The Corporation did not receive the notification card regarding the annual report and Jonathan Guerrero, the sole shareholder effective October 17, 2003, was not aware of the filing requirement.
