BEFORE ME, the undersigned authority, this day personally appeared Adrian Jorge Romero who first by me being duly sworn deposes and says:

That pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

First: The name of the Corporation will be amended, from J & S Marketing & Management Services Inc. to Southern Eagle Cargo, Inc.
