ARTICLES OF INCORPORATION

OF

ARTICLE I- NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this corporation is MED-TRANSPORTATION, INC. and its principal place of business shall be located at 144 Jefferson Street, Lake Wales, FL 33853

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV- CAPITAL STOCK

This corporation is authorized to issue **100** shares of common stock, with an assigned value of \$1.00 per share and shall designated as "Common Shares."
