ARTICLES OF INCORPORATION

OF

ARTICLE I- NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **MED-TRANSPORTATION, INC.** and its principal place of business shall be located at **144 Jefferson Street, Lake Wales, FL 33853**

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.
