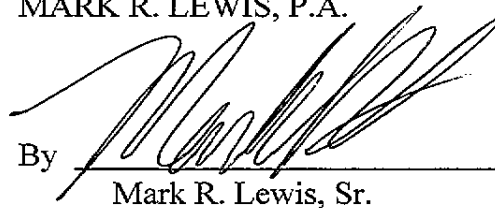

Pursuant to Section 607.1402 and 607.1403 of the Florida Statutes, the undersigned Corporation adopts these Articles of Dissolution.

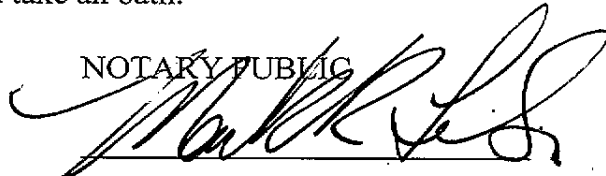
