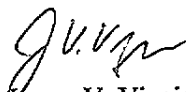

The number of shares of stock that this corporation is authorized to have outstanding at any one time is: 100 (one hundred) shares of common stock.

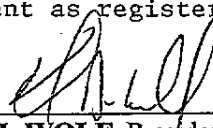
ARTICLE IV – INITIAL REGISTERED AGENT AND ADDRESS
