

**ARTICLES OF INCORPORATION

**ARTICLE I. CORPORATION NAME**

The name of the corporation is:

**ARTICLE II. NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this Corporation is to engage the sale and listing of real estate as permitted under the laws of the State of Florida.

**ARTICLE III. CAPITAL STOCK**

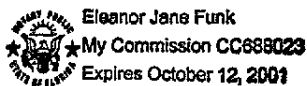




