The name of this corporation shall be:

changed or replaced by either the Stockholders or the Directors of the corporation at any duly scheduled Special Meeting called for that purpose.


#### ARTICLE XII

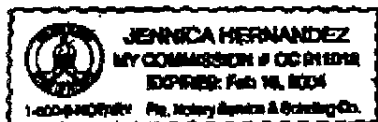


