<u>OF</u>

NORTON FINANCE, INC.

<u>ARTICLE I</u>

NAME AND ADDRESS

The name of this corporation is NORTON FINANCE, INC. and its principal address is 350 5th Avenue South, Suite 202, Naples, Florida 34102.

ARTICLE II

DURATION

This corporation shall exist perpetually commencing on the date of execution of these Articles of Incorporation.

ARTICLE III

<u>PURPOSE</u>

This corporation is organized to engage in the business of acting as a mortgage broker, issue mortgages and financing, investments, and for all other purposes allowed a Florida corporation.

ARTICLE IV

CAPITAL STOCK

The corporation is authorized to issue 7,500 shares of One Dollar (\$1.00) par value common stock.

ARTICLE V

<u>INITIAL REGISTERED OFFICE AND AGENT</u>

ARTICLE VIII

BY-LAWS

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

ARTICLE IX

SHAREHOLDER QUORUM

Sixty percent of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of the shareholders.

ARTICLE X

APPROVAL OF SHAREHOLDERS REQUIRED FOR MERGER

for the corporation or on the books and records of the corporation, or followed what he believed to be sound accounting and business practice.

PREEMPTIVE RIGHTS

Every shareholder upon the issuance or sale of any new stock of this corporation of the same kind or class as that which he already owns, shall have the preemptive right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

AMENDMENT


