ARTICLES OF INCORPORATION
OF

Article I

The name of this corporation shall be:

PRESTIGE DRIVING SCHOOL, CORP.

Article II

This corporation may engage in the transaction of any or all-lawful business under the laws of the United States and the State of Florida.

Article III

The maximum number of shares of stock authorized to be issued by this corporation at any time is 500 shares of \$ 1.00 par value each.

Article IV

The shareholders of this corporation shall have preemptive rights to acquire unissued or treasury shares of the corporation, or securities of the corporation convertible into or carrying a right to subscribe to or to acquire shares of the corporation to the extent that the stockholders might so specifically set forth. Lacking this affirmative action by the stockholders there shall be no such preemptive rights.

Article V

This corporation is to have perpetual existence.

Article VI

The principal office of this corporation shall be located at: 1750 W. 56th St. # 205, Hialeah, FL 33012. _____ with the corporation retaining the power of moving its office to any other address in Florida, as may from time to time be determined and authorized by its Board of Directors, with branch offices in such other cities, or countries as may from time to time be authorized by its Board of Directors.

Article VII

The initial registered office of this corporation shall be at 1750 W. 56th St. # 205, Hialeah, FL 33012. _____

The initial registered agent at such address shall be: Martha Justa de Zayas.

Article VIII

This corporation shall at all times have at least one and not more than five Directors who shall conduct the business of the corporation as a Board of Directors. The Stockholders of this corporation may, from time to time, and at any time, increase or decrease the size of the Board of Directors of the corporation.

The right of indemnification herein provided for shall not be exclusive of other rights to which any such person may now or hereafter be entitled as matter of law.
