The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME.**

The name of the corporation shall be: Aviation Logistics Management, Inc.

**ARTICLE II. ADDRESSES.**
