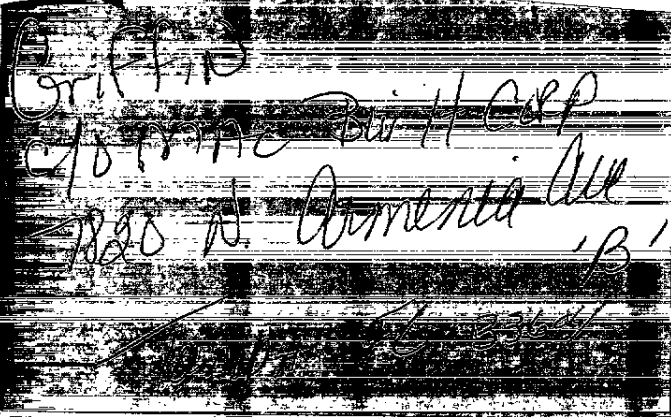

## ARTICLES OF INCORPORATION

REBECCA S. ECKLEY, P.A.

### ARTICLE ONE

1.01 THE NAME OF THE CORPORATION IS REBECCA S. ECKLEY, P.A.

### ARTICLE TWO (NATURE OF BUSINESS)

2.01 THE CORPORATION MAY ENGAGE IN ANY ACTIVITY OF BUSINESS PERMITTED UNDER THE LAW OF THE UNITED STATES AND OF THIS STATE. THE DUTIES AND FUNCTIONS OF THE CORPORATION IS TO ACT AS A REAL ESTATE AGENT.
