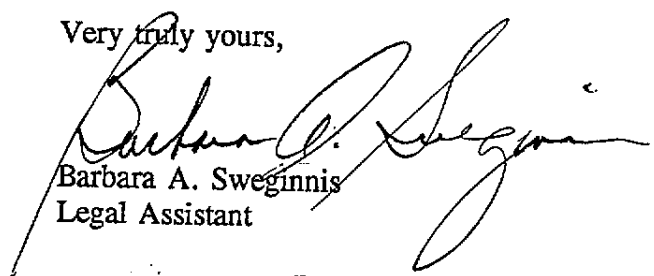

ARTICLE I - NAME

The name of the corporation is: - FINII, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The purpose of this business is to perform any and all lawful business in the State of Florida.

ARTICLE IV - STOCK

This corporation is authorized to issue ONE HUNDRED (100) shares of Common Stock, \$.01 par value, which shall be designated as "Common Shares".

ARTICLE V - PREFERENCES, LIMITATIONS AND
