**ARTICLES OF INCORPORATION
OF
BATES/NAIL CARE, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation is BATES/NAIL CARE INC.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III
