## ARTICLES OF INCORPORATION OF ALL PRO HANDY MAN, INC.

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE	1
<u>NAME</u>	

The name of this Corporation is: ALL PRO HANDY MAN, INC.

## ARTICLE 2 PRINCIPAL OFFICE AND MAILING ADDRESS

The initial address of the principal office and the mailing address of this Corporation in the State of Florida is 5226 30<sup>TH</sup> Avenue South, Gulfport, FL 33707.

## ARTICLE 3 CAPITAL STOCK

- 1. <u>Authorized Capitalization</u>. The total number of shares of capital stock authorized to be issued by this Corporation shall be 500 shares of common stock, par value \$1.00 per share (the "Common Stock").
- 2. Payment for Stock. All or any part of the consideration for the issuance of the capital stock of this Corporation may be in cash, property or labor or services at a fair valuation to be fixed by the Board of Directors at a meeting called for that purpose, which consideration, in any event, shall not be less that the par value of the shares issued therefor. All stock when issued shall be fully paid and nonassessable.
- 3. <u>Voting</u>. The voting power of this Corporation shall be vested solely in the Common Stock. Holders of shares of Common Stock shall be entitled to one vote for each share of Common Stock. There shall be no cumulative voting in the election of directors.
- 4. <u>Dividends</u>. Any and all dividends are to be shared among the holders of shares of outstanding Common Stock on a share for share basis.

### ARTICLE 4 REGISTERED OFFICE AND REGISTERED AGENT
