FOR THIS REASON OUR CLIENT DID NOT RECEIVE THE 2002 UNIFORM BUSINESS REPORT NOR ANY OTHER CORRESPONDENCE REGARDING ANY THING TO DO WITH PERFORMANCE PRESENTATIONS, INC. OUR CLIENT WAS NOT AWARE THAT HE WAS IN DEFAULT OF FILING THIS REPORT UNTIL JUST RECENTLY WHEN HE

ATTEMPTED TO OPEN A CORPORATE CHECKING ACCOUNT AND THE BANK ADVISED HIM THAT HE WAS NOT REGISTERED AS AN ACTIVE CORPORATION.
