### ARTICLES OF INCORPORATION

OF

# THE P, B, & B PROPERTY MANAGEMENT COMPANY

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

#### ARTICLE I

The name of the Corporation is THE P, B, & B PROPERTY MANAGEMENT COMPANY

## ARTICLE VII


This Corporation is authorized to issue 15,000 shares of common stock with a par value of \$1.00 per share.
