# ARTICLES OF INCORPORATION

OF

#### PENNACHIO AGENCY, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### ARTICLE I - Name

The name of the corporation is PENNACHIO AGENCY, INC.

# ARTICLE II - Principal Office and Mailing Address of the Corporation
