ARTICLES OF INCORPORATION

OF

JOHN J. PENNACHIO, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is JOHN J. PENNACHIO, INC.
