We are the Certified Public Accountants for the above referenced taxpayer and are writing to you on their behalf.

Enclosed is the 2002 Uniform Business Report (UBR) for Elaya, Inc along with a check for \$150 for the filing of this report. We respectfully request that the \$400 late filing fee associated with filing after May 1, 2002 be abated. This is the taxpayer's initial UBR and the officer's were unfamiliar with the filing requirements and consequently this report is being filed late. The corporation is only just now beginning operations and commenced reviewing all correspondence from the Internal Revenue Service and the Florida Department of Revenue. The officers of the corporation had set all this correspondence aside believing that it was informational and that since the corporation was inactive they were not required to file any returns etc.

We respectfully request that since this is the corporation's initial Uniform Business Report and the failure to file in a timely manner was unintentional that the \$400 penalty be abated.
