ARTICLE I. NAME

THE NAME OF THIS CORPORATION IS PASS & ASSOCIATES FINANCIAL SERVICES, INC.

ARTICLE II. DURATION OF THE CORPORATION

THIS CORPORATION IS TO EXIST PERPETUALLY.
