**ARTICLES OF INCORPORATION
OF
ALLISON BRANDSTETTER, P.A.**

I, the undersigned incorporator, who is licensed or otherwise legally authorized to practice the profession of law or perform legal services in the State of Florida, hereby manifest my intention to form a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and adopt the following articles of incorporation:

ARTICLE I

Name

Duration

The existence of the Corporation shall begin upon the filing of these Articles of Incorporation and shall exist perpetually.

ARTICLE IV

Purpose

This corporation is organized for the following purposes:

- a. To engage in the practice of law as a professional law corporation and to carry on services incident to the practice of law. The practice of law is the sole and exclusive professional service to be rendered by this corporation.

Corporate Powers

The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida.

Amendment



The Corporation shall indemnify its directors and officers to the fullest extent permitted by law.


