**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION  
of  
ALL SOURCE RECRUITING GROUP, INC.**

The Articles of Incorporation of All Source Recruiting Group, Inc., a Florida corporation (the "Corporation"), filed with the Department of State on August 28, 2001, as Document Number P01000085230, and as amended by those certain Articles of Amendment filed on September 7, 2006, be and they hereby are amended as set forth below:


Article 6.1 of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the following:

**ARTICLE 6 - CORPORATE CAPITALIZATION**

6.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is Twenty Five Million (25,000,000) shares of common stock, each share having a par value of \$1.00.

The foregoing amendment was adopted by a written consent action dated September 24, 2015. The number of votes cast by the Shareholders and Directors in favor of the foregoing amendment was sufficient to approve the foregoing amendment.
