ARTICLES OF INCORPORATION OF

ARTICLE I.
CORPORATE NAME

The name of this corporation shall be: Neil H. Weisman, M.D.,

ARTICLE II.
NATURE OF CORPORATE BUSINESS

The Corporation shall engage in business of providing all medical health services and consultation that the medical practitioner(s) and staff of the corporation are licensed and authorized to provide under the laws of the State of Florida and the United States of America.

ARTICLE III.
CAPITAL STOCK

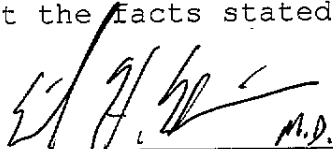

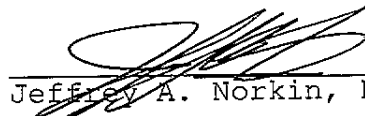
