The undersigned, for purposes of forming a corporation under the Florida Corporation and Limited Liability Company Act, does hereby adopt the following Articles of Incorporation:...

ARTICLE I NAME

The name of the corporation shall be Gary L. Green, P.A.

ARTICLE II PRINCIPAL OFFICE
