The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is City of Legends, Inc.

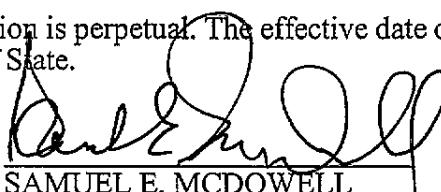

The period of its duration is perpetual. The effective date of Incorporation shall be the date of filing with the Secretary of State.

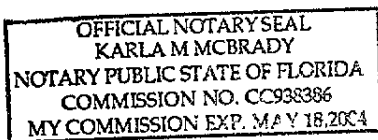

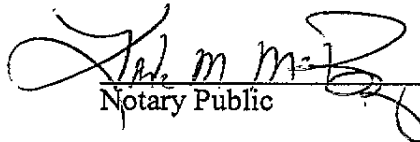

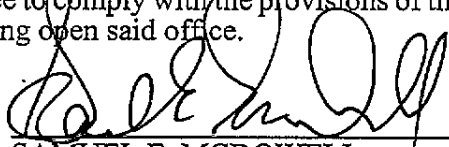
