ARTICLES OF INCORPORATION
OF

The undersigned incorporator, RICHARD OLSON, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

ARTICLE II - PRINCIPAL OFFICE


ARTICLE X - COMMENCEMENT OF CORPORATE EXISTENCE

The date for commencement of this corporation's existence shall be the date these Articles are filed and approved by the Florida Department of State, Division of Corporations.


ARTICLE XI - AMENDMENT
