The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida. SECRETARY OF STATE
TALLAHASSEE FLORIDA

ARTICLE I: NAME

The name of the corporation shall be:

E-CONNECTIONS INC.

The principal place of business and mailing address of this corporation shall be 1506 Glendale Street, Jacksonville, FL 32205, and P.O. Box 380039, Jacksonville, FL 32205

ARTICLE II: NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, county, territory or nation.

ARTICLE VIII: EFFECTIVE DATE






