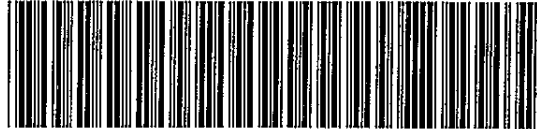

**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
PEACHIE SCARANO, MD**

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida professional corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Amendments adopted:

Article I. Name: The name of the corporation shall be **Joseph & Peachie Scarano, P.A.**

Article II. Principal Office: The principal place of business/ mailing address is: 4861 26th Street West, Bradenton, Florida, 34207.

Article III. Purpose: The purpose for which the Corporation is organized is to practice the profession of medicine.
