

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is BUCCANEER WRECKING, INC.

ARTICLE II.

The main location where the company shall conduct its business is 973 Lake Asbury Drive, Green Cove Springs, Florida 32043.

ARTICLE III.

The duration of the corporation shall be perpetual.

ARTICLE IV.

The purpose of the corporation shall be the demolition of commercial and residential structures and for any other lawful purpose for which corporations for profit are incorporated under the laws of the State of Florida.

ARTICLE V.

The method of election of directors shall be as stated in the corporate by-laws.

The aggregate number of shares which the corporation shall have authority to issue is One Hundred (100) shares of common stock with a par value of Five Dollars (\$5.00) per share.


ARTICLE VII.

The name and address of the sole incorporator is Gary Pope, 973 Lake Asbury Drive, Green Cove Springs, Florida 32043.



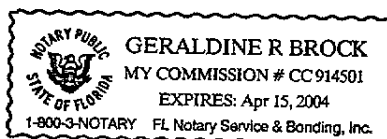
