ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF AVALON POINTE APARTMENTS, INC.

The undersigned, as President of AVALON POINTE APARTMENTS, INC., a Florida corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to the terms of Chapter 607, <u>Florida Statutes</u>, the Florida Business Corporation Act (the "Act"), states as follows:

- 1. The current name of the Corporation is AVALON POINTE APARTMENTS, INC.
- 2. The date of the filing of the original Articles of Incorporation of the Corporation was August 31, 2001.
- 3. The Articles of Incorporation of the Corporation are amended by deleting Article I entitled "Name" in its entirety and inserting the following section in its place and stead:

ARTICLE I - NAME

The name of the company is COX CREEK COVE, INC.

4. This amendment to the Articles of Incorporation of the Corporation was approved by an Action of the Directors in Lieu of Special Meeting dated as of August 33 2002. Shareholder Action was not required for the filling of this amendment.
