Pursuant to Section 607.1006 of the Florida Business Corporation Act, the undersigned, being an officer of Norseman Plastics, Inc., a Florida corporation, hereby certifies as follows:

1. The name of the corporation is Norseman Plastics, Inc. (the "Corporation").
2. Article II of the Articles of Incorporation of the Corporation (the "Articles of Incorporation") is hereby amended to read in its entirety as follows:

ARTICLE II
