

ARTICLES OF INCORPORATION OF ALPHA PROPERTIES OF NORTH FLORIDA, INC.

These Articles of Incorporation (the "Articles") are hereby executed this 4th day of September, 2001, by the undersigned incorporator (the "Incorporator"), who submits these articles for the purpose of forming a corporation (the "Corporation").

- Name. The name of the Corporation shall be "ALPHA PROPERTIES OF NORTH FLORIDA, INC."
