OF

NAME**

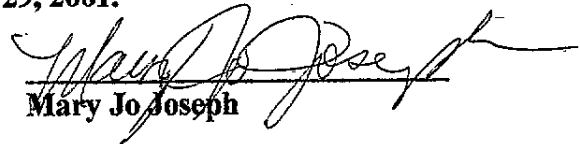
Article 8.

shareholders is subject to this reservation.

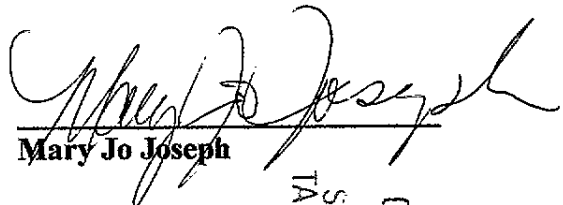
