ARTICLES OF INCORPORATION

OF

ARTICLE I NAME

The name of the OCALCO, INC.. The address of the Corporation is 17908 Arbor Greene Drive, Tampa, Florida 33647.

ARTICLE II DURATION

The Corporation shall have perpetual existence.
