ARTICLE I
NAME

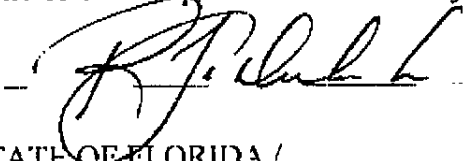
ARTICLE X ACTION BY DIRECTORS AND STOCKHOLDERS WITHOUT A MEETING

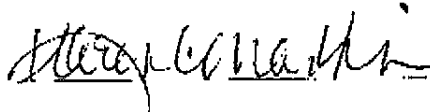

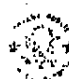
