DURATION:

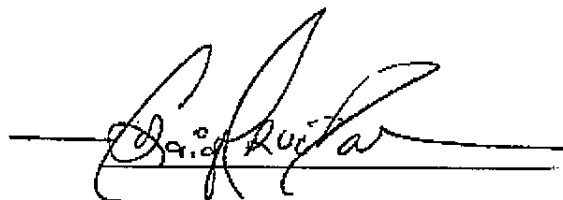

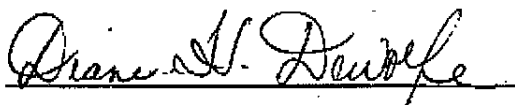

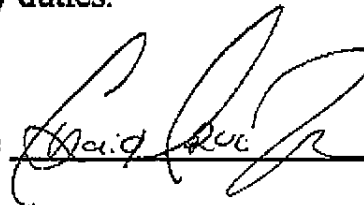
