ARTICLES OF INCORPORATION

contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is T & J NURSERY, INC..

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in any activity of business permitted under the laws of The United States and of the State of Florida.

ARTICLE III. POWER
