Dear Division Representative:

In requesting a Certificate of Status from your office just a few days ago, I first learned that People 2.0 Global, Inc. (of which I am Vice President) had not filed a required annual report for 2001. Our corporation was formed late in 2001 and neither my partner nor I were aware of the requirement for an annual report.

I was told by a Division representative that a request for a report was mailed to our Registered Agent. That request was never received by any representative of People 2.0. When our corporation was first set up by a local attorney (Mr. Keith Kanouse), he named himself as our Registered Agent. Since then, Mr. Kanouse left Florida and relocated to Georgia. He no longer represents People 2.0.

I am now submitting a Uniform Business Report that includes a request for a change of Registered Agents. I am also submitting the standard, \$150.00 registration fee and respectfully requesting that any penalties or reinstatement fees be waived under the circumstances described above.

Finally, please note that our check is in the amount of \$167.50. This is to include the added cost of two Certificates of Status. Because we are facing a short deadline, I am asking that the Certificates be expressed at your earliest convenience in the FedEx envelop provided.
