of

ARTICLE I

NAME

The name of this corporation is La Selecta Fish Market Inc.

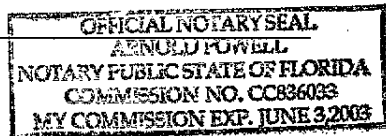
