

# ARTICLES OF INCORPORATION OF

Express Gourmet Deli Inc.



## ARTICLE I - NAME

The name of this corporation is Express Gourmet Deli Inc.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence.

### ARTICLE III - PURPOSE
