# ARTICLES OF INCORPORATION OF Johns Quality Decorating, Inc.

The undersigned incorporator to these Articles of Incorporation hereby form a corporation under the laws of the State of Florida as follows:

#### ARTICLE I

# Name and Address

The name of this Corporation is: Johns Quality Decorating, Inc. The street address of the Corporation is: 6130 Cypress Hollow Way, Naples, Florida 34109

#### ARTICLE II

# Term of Existence

This Corporation shall have perpetual existence, commencing upon filing of these articles of incorporation with the Florida Secretary of State.

#### ARTICLE III

#### Purpose

This Corporation is organized for the purpose of transacting any and all lawful business Painting residential, commercial properties and furniture.

#### ARTICLE IV

#### Powers

The Corporation shall have the power:

- (a) To have perpetual succession by its corporate name.

- (h) To make contracts and guaranties and incur liabilities, borrow money at such rates of interest as the Corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
- (i) To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.

(j) To conduct its business, carry on its operations, and have offices and exercise the powers granted by the Florida General Corporation Act within or without the State of Florida.

(k) To elect or appoint officers and agents of the Corporation and define their duties and fix their compensation.

(1) To make and alter bylaws, not inconsistent with these Articles of Incorporation and the laws of this state, for the administration and regulation of the affairs of the Corporation.
