ARTICLES OF INCORPORATION

OF

DARRELL GOODSON CONCRETE APPLICATIONS, INC.

We, the undersigned incorporators, for the purpose of forming a corporation under Florida law, hereby incorporate ourselves and adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be:

DARRELL GOODSON CONCRETE APPLICATIONS, INC.

ARTICLE II: PURPOSE

DARRELL GOODSON CONCRETE APPLICATIONS, INC. shall be organized under Florida Statute Chapter 607 as a for-profit corporation with the purpose of general contracting as well as specific contracting with regards to concrete detailing-esthetics-sculpting and other concrete design work.

DARRELL GOODSON CONCRETE APPLICATIONS, INC. may invest its corporate funds into real estate, mortgages, stocks, bonds, and any other type of investments, and may own real and personal property necessary for the rendering of the services

authorized hereby. Further, DARRELL GOODSON CONCRETE APPLICATIONS, INC., may engage in any and all other lawful corporate activities.

ARTICLE III: PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be in Palm Beach County, Florida.

ARTICLE IV: MAILING ADDRESS

ARTICLE V: SHARES

The maximum number of shares of stock that this for profit corporation is authorized to have outstanding at any one time shall be one hundred (100) shares with an initial par value of two hundred dollars (\$200.00) per share, all of which shall be common stock of the same class.

ARTICLE VI: OWNERSHIP OF SHARES

DARRELL GOODSON, acting as Co-Director of DARRELL GOODSON CONCRETE APPLICATIONS, INC., shall be issued and hold fifty (50) shares of common stock of DARRELL GOODSON CONCRETE APPLICATIONS, INC.

NANCY GOODSON, acting as Co-Director of DARRELL GOODSON CONCRETE APPLICATIONS, INC., shall be issued and hold fifty (50) shares of common stock of DARRELL GOODSON CONCRETE APPLICATIONS, INC.

The Co-Directors shall hold their shares of common stock as joint tenants with right of survivorship, and upon the death of one of the Co-Directors, the deceased Co-Director's shares shall pass immediately to the remaining surviving Co-Director.

ARTICLE VII: EXISTENCE

The corporation shall have perpetual existence.

ARTICLE VIII: BOARD OF DIRECTORS/INCORPORATORS

The name and post office address of the first board of directors/incorporators, who subject to the provisions of these Articles of Incorporation shall hold office for the first year of the corporation's existence or until their successors are elected and have qualified, are as follows:

ARTICLE IX: MANAGEMENT/AFFILIATION

In furtherance and not in limitation of the powers conferred by statute, the following specific provisions are made for the regulation of the business and conduct of the affairs of DARRELL GOODSON CONCRETE APPLICATIONS, INC.

- (1) Such directors/shareholders of DARRELL GOODSON CONCRETE APPLICATIONS, INC. shall from time to time create, readdress and amend by-laws for the corporation as the directors/shareholders should see fit.
- (2) Subject always to such by-laws as may be adopted from time to time by the stockholders, the board of directors of DARRELL GOODSON CONCRETE APPLICATIONS, INC. is expressly authorized to adopt, alter and amend the by-laws of the corporation, but any by-law adopted, altered or amended by the directors may be altered, amended or repealed by the stockholders.
