**Article I - Name**

The name of this corporation is Law Office of Jodi Cason, P.A.

**Article II - Duration**

This corporation shall exist perpetually.

**Article III - Purpose**

The general purpose of the business to be transacted by this corporation is to provide legal services, and to manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property and services of every class, kind and description; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone, or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair, or exposition.

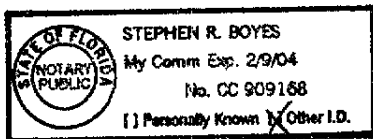
