ARTICLES OF INCORPORATION

OF

Brad Campbell Insurance Agency, Inc.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is **Brad Campbell Insurance Agency, Inc.** and its principal office and mailing address is: **13510 N. Tamamiami Trail, Naples, FL 34110.**

ARTICLE II - NATURE

The nature of the business to be transacted by this corporation is: insurance sales and service. To erect dwellings, apartment houses and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave and dedicate roads, streets, avenues, highways, alleys, courts, paths, walks, parks, cemeteries and playgrounds. To buy, sell, mortgage, exchange, lease, let, hold for investment or otherwise, use and operate real estate of all kinds, improved or unimproved; and any right or interest therein.

To manufacture, purchase, or otherwise acquire and to own, mortgage,
