The undersigned subscriber to these Articles of Incorporation, Lorayne R. Goodfellow, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is K.L.D.T.A. INC. The principal office and mailing address of the corporation is 463 Golfview Drive, Naples, Florida 34110.


