In compliance with the requirements of F.S. Chapter 607, the undersigned, being a legal person, do hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is **Impulse Distributing, Inc.**

ARTICLE II

The existence of the corporation shall begin on September 6, 2001.

ARTICLE III

The street address of the principal office of the Corporation is 1481 P Market Circle, Port Charlotte, Florida 33953.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares.
