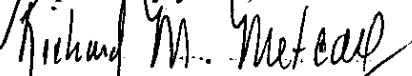

Dear Division of Corporations:

Yesterday I talked with one of your representatives by telephone about the pending Dissolution notice we received and was informed that the reason it was rejected is because there was a change in procedure that mailing addresses could not be a PO Box number.
